police on the Delhi-Lucknow National Highway on June 10/11, 1977. Another escapee, Davinder, has been rearrested by the Delhi Police on 19th June, 1977.

HOI Written Answers

(c) An enquiry into the escape of the undertrial prisoners mentioned above has been ordered by the Lt. Governor, Delhi. The circumstances leading to the escape of the undertrials and security arrangements, including construction of judicial lockup cells to preclude the possibility of such incidents happening in future, will be looked into during the said enquiry. The changes in the Jail Manual regarding production of prisoners undertrials in Courts, handing them over to the police, guards etc. will also be recommended, if considered necessary.

Expansion in Vikram Sarabhai Space Centre during 1977-78
