Tractor Factory, Pratapgarh

THE MINISTER OF INDUSTRY (SHRI BRIJLAL VERMA); (a) As reported by M/S, Auto Tractors Ltd., which is a Govt. of U.P. enterprise, the land has been acquired, fencing work partically completed, field hostel construction in progress and nucleus design/process engineering/materials management staff in position.

- (b) As estimated by the firm, the ex-factory selling price of the tractor would be Rs. 37,000/-. They plan to produce 500, 1500 2500, 4000 and 6000 tractors during first five years of commencement of production.
- (c) The State Government have allocated Rs. 50 lakhs, so far.
