- (a) the total number of policemen and officers employed in the Border Security Force and the nature and actual states of their operations during the last 3 years (1974, 1975 and 1976) in the various parts of the country;
- (b) whether Government propose to formulate a new policy regarding deployment and use of the B.S.F.;
  - (c) if so, broad details thereof; and
- (d) the total cost to the exchequer for the maintenance of the B.S.F. in the year 1974, 1975 and 1976?

THE MINISTER OF HOME AF-FAIRS (SHRI CHARAN SINGH): (a) and (d). A statement showing the sanctioned strength of the B.S.F. and the expenditure incurred on the Force during 1974, 1975 and 1976 is attached. During these years. BSF mainly remained deployed on border security duties on the international borders. However, occasionally it was made available to the State Governments, at their request, to assist them in the maintenance of law and order.

(b) and (c). The changes brought about by Article 257-A of the Constitution in regard to the deployment of BSF and other para-Military forces would be reviewed alongwith the other provisions of the 42nd amendment to the Constitution in due course.
