## Corruption in IISCO

Written Answers

5221. SHRIMATI PARVATHI KRISHNAN: Will the MINISTER of STEEL AND MINES be pleased to state:

- (a) whether the Government, attention has been drawn to the news appeared in the Business Standard dated 28th June, 1977 under the caption "Corruption" ruling the roost in IISCO; and
- (b) if so, what is Government's reaction and details thereof?

THE MINISTER OF STEEL AND MINES (SHRI BIJU PATNAIK): (a) Yes, Sir.

- (b) The allegations made in the news item are not based on facts. The position with regard to the main allegations is as under:—
  - (i) It is not true that the officers against whom C.B.I. enquiries are pending have been promoted after the institution of such enquiries.
  - (ii) Supply of steel in "package deal" is a normal trade practice. It is adopted in order to get the best advantage of fast selling items having premium in the market along with slow moving materials which would not sell otherwise: however, this matter is being reviewed.
  - (iii) The allegations relating to partiality shown to some traders are also not borne out by facts. There was no offer, nor is there any at present, for the supply of 1845 tonnes of GC sheets to any particular trader.
  - (iv) At present there is no facility of clean credit; credit is given to traders only against bank guarantees. This is being followed uniformly in all cases.
