- (b) if so, what is the order of investment proposed during the current year on this account, zone-wise, and proposed investment in the Central Zone in particular; and
- (c) the estimated man days of employment is likely to be generated as a result of the proposed investment?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SHEO NARAIN): (a) No such decision has been taken so far.

- (b) Does not arise.
- (c) Construction of railway lines results in direct employment in the project area and also very substantial indirect employment in industries like brick burning, cement and steel, rails and sleepers etc. A railway line also generates employment on long term basis directly for its operation and indirectly by stimulating the economic development of the area served. It is difficult to make a precise assessment of the direct and indirect employment which a railway line may generate during and after its construction.

Government Companies, their paid up Share Capital, Profits and Losses

299. SHRI PARMANAND GOVIND-JIWALA: Will the Minister of LAW. JUSTICE AND COMPANY AFFAIRS be pleased to state:

- (a) the total number of Government companies including their subsidiaries at work as on the 2nd October, 1977 and the aggregate pald up share capital of these companies; and
- (b) their profits and losses as on the 2nd October, 1977?

THE MINISTER OF LAW, JUSTICE AND COMPANY AFFAIRS 'SHRI SHANTI BHUSHAN): (a) As on 30-9-1977, the number of Government companies (both Central and States) was 712 and their aggregate paid-up capital amounted to Rs. 7314.5 crores.

(b) According to the information furnished by the Bureau of Public Enterprises, the total net profit before taxation of Central Government companies during 1976-77 amounted to Rs. 498.92 crores (provisional) excluding insurance corporations, the National Textile Corporation and its subsidiaries and the companies registered under section 25 of the Companies Act (non-profit making organisations). Similar information in regard to all State Government companies is not yet available.

Improvement of Railway Lines in M.P.

300. SHRI PARMANAND GOVIND-JIWALA:

SHRI HUKAM CHAND KACH-WAI:

Will the Minister of RAILWAYS bepleased to state:

- (a) what is the total number of provisions and technical surveys for the improvement of Railway lines in Madhya Fradesh made and constructed within the last three years;
- (b) what was the discounted cash flow return on each survey line and the decisions thereof;
- (c) what is the estimated income of the proposed railway line Delhi-Rajthara-Jagdalpur via Narayanpur-Kodagaon to be connected to Howrah-Bombay Railway line; and
- (d) has any work commenced on the above proposed line?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SHEO NARAIN): (a) 19 major schemes for improving the line capacity of existing lines are in progress in Madhya Pradesh. 10 surveys for improving the existing lines and 10 surveys/constructions of new lines/gauge conversions were carried out during the last three ears or are in hand at present.

(b) and (c). Statistics of ticketless travel are maintained railway-wise and not state-wise. It is, therefore, not possible to furnish the requisite information.

Value of Jobs done by R.D.S.O.

302. SHRI SAMAR MUKHERJEE: Will the Minister of RAILWAYS be pleased to state:

- (a) the value of jobs done by Reseach, Designs and Standards Organisation for Indian Railways through their gervice to the Zonal Railways, railway manufacturing workshop, etc. during the last three years; and
- (b) the names of parties for whom they worked?

THE MINISTER OF STATE MINISTRY OF RAILWAYS (SHRI SHEO NARAIN): (a) Jobs done by the R.D.S.O. for the Zonal Railways, Production Units etc., are considerable volume and include development of new designs, service engineering, technical consultancy, developmental inspection and improvement or modifications of the existing design, and standards and specifications. 'The value of these jobs have not been estimated in financial terms. Being an attached office of the Ministry of Railways, the services rendered by it are not charged to the Railways.

(b) Apart from the Zonal Railways, Production Units and other Organisations under the Ministry of Railways, the R.D.S.O. rendered assistance in the form of consultancy and other services to various private/public sector undertakings in the country and a few foreign railways listed in the Statement attached.
