Shifting of South Eastern Railway Headquarter

(a) whether lots of representations have been made in the past pressing hard the demand that South Eastern Railways Headquarters should be immediately shifted to Khurda Road in view of the increase in quantum of traffic in-flow and goods carriage in Orissa: and

(b) if so, what action has been initiated in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHR! SEO NARAIN): (a) and (b). A few representations have been received in the past for shifting the headquarters of South Eastern Railway to Khurda Road in Orissa.

These representations were duly considered but on both operational and administrative grounds it was decided to maintain the status quo.

Construction of Broad Gauge Lines in Maharashtra

Will the Minister of RAILWAYS be pleased to state:

- (a) whether it is a fact that survey had been carried out as far back as seventeen years, for Latur-Pandharpur-Miraj Railway track in Maharashtra State for construction of broad gauge:
- (b) what is the estimated cost of the project;
- (c) whether Government did not take up the project till today on the plea of paucity of funds;
- (d) whether Government are aware that lakhs of people from all over India visit Pandharpur annually for darshan of God Vitthal; and
- (e) in view of the several representations including from State of Maharashtra urging upon the construction of broad gauge of the said rail track, will Government have a new look over the project?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SHEO NARAIN): (a) Yes, a Preliminary Engineering-cum-Final Location Survey (along with a traffic survey) was carried out for converting Miraj-Pandharpur-Kurdwadi-Latur section from narrow gauge to broad gauge.

(b) The cost of the project Miraj-Latur conversion to B. G. was estimated as Rs. 43.12 crores.

- (c) Yes.
- (d) Yes.
- (e) It will be possible to consider the project for construction when there is improvement in the availability of resources.

(a) and (b). No, Sir. Part-II of the Report of the Committee on Fertilizer Prices dealing with phosphatic fertilizers and freight is expected to become available shortly.
