THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI JAG-DAMBI PRASAD YADAV): (a) A central team of experts conducted a random survey of selected villages in four districts of Muzzaffarpur, shali, Samastipur and Sitamadhi which were mainly effected by Kalazar from 7th to 22nd August, 1977.

- (b) Yes.
- (c) The assistance extended by the Government of India to the Government of Bihar consists of the following:---
 - 1. Insecticides, spray equipment, operational support has been provided by diversion of funds from National Malaria Eradication Programme.
 - 2. A strategy for control has been worked out in consultation with the Government of Bihar.
 - 3. While the Government of Bihar is procuring the indigenously available anti-mony compounds. Government of India procured Pentamidine Lomodine drugs through the WHO and supplied them to the Government of Bihar.
 - 4. Provided epidemiologists continuously evaluate the Kalazar activities.
 - Designed a search in 31 districts by house to house visit health workers. Due to strike State Health employees in this could not, however, be undertaken so far.

Agricultural Workers

620. SHRI CHITTA BASU: SHRI PHOOL CHAND. VERMA:

Will the Minister of PARLIAMEN-TARY AFFAIRS AND LABOUR pleased to state:

- (a) the total number of agricultural workers in the country;
- (b) the condition of their life and work; and
- (c) the steps taken by Government to ameliorate their conditions?

THE MINISTER OF STATE IN THE MINISTRY OF LABOUR PARLIAMENTARY AFFAIRS (SHRI LARANG SAI): (a) and (b). According to the 1971 Census agricultural workers in India number about 47.5 million. Their problems, as highlighted from time to time by various forums and Rural Labour Enquires, are, generally, low wages and the resulting low standard of living, unemployment and underemployment and lack of Organisation.

(c) To ameliorate conditions of life of the weaker section in rural areas, including agricultural workers, 160 Small Farmers' Development Agencies/ Marginal Farmers and Agricultural Labourers Projects were functioning in the country during 1976-77, the main emphasis in the projects being on crop hubandry which includes Intensive Agricultural Multiple Croppintroduction of high yielding varieties, development of minor irrigation, soil conservation, land devclopment etc. These Agencies have also been authorised to implement the usual animal husbandry programmes like distribution of milch cattle, poultry, goat and sheep rearing, piggery etc. The problems of labour in the unorganised sector, including agricultural workers were discussed at the recent Tripartite Labour Conference held on 6-7th May, 1977. The general consensus at the Conference was that, having regard to the various complex issues involved, a Special Conference be convened to consider the problems relating to unorganised rural labour, including, agricultural workers, the nature of subjects to be discussed and nature of participants to the proposed Conference settled in ation with the interests concerned, including the State Governments/ Union Territories, Central Organisations of Workers and Employers etc. The suggestions received from these interests are being examined and steps are being taken to convene the proposed Special Conference soon to discuss the problems of agricultural workers. 2416 LS-3
