(d) About 28 per cent of the tea imported by USSR is re-exported mainly to the Socialist countries in Europe. The names of the countries of origin of these teas and the prices at which these teas are re-exported are not available. Re-export of tea by importing countries is a feature of this trade. Other countries which also re-export tea on a sizeable scale are U.K., Netherlands, Canada and on a smaller scale Ireland, France and West Germany. Government is, however, not aware of anysizeable re-export of Indian tea by USSR to EEC or to other free market countries.

(e) W_{c} are already exporting tea to about 80 countries of the world including the convertible currency countries. Ilke the USA. Canada, UK and some European countries. A continuous effort is also being made to further increase our exports to these countries. Export of tea to USSR is subject to a ceiling fixed every year, having regard to the total availability of tea for export. This does not, therefore, affect our anticipated earnings of free foreign exchange from tea exports.

In pursuance of these instructions, most of the enterprises have already set up appropriate vigilance organisations to meet their requirements. According to information available the post of Chief Vigilance Officer has been vacant for vary_ ing periods in four major enterprises viz. Indian Airlines, Oil and Natural Gas Commission. Hindustan Antibiotics and India Tourism Development Corporation. Arrangements have. however, been made to look after vigilance work in these enterprises.
