Historical Facts of Ramayana and Bhagwat Geeta

4370. SHRI MADHAVRAO SCIN-DIA: Will the Minister of EDUCA-TION, SOCIAL WELFARE AND CULTURE be pleased to state:

(a) whether his attention has been drawn towards the articles appearing in the fortnightly magazine (Hindi) 'Sarita' published from Delhi about the distortion of historical facts of Ramayan and Bhagwat Geeta which is creating adverse public reaction;

(b) if so, his reaction thereon; and

(c) the steps Government propose to take to prevent this magazine from publishing such anti-social articles keeping in view the adverse public reaction?

THE MINISTER OF EDUCATION, SOCIAL WELFARE AND CULTURE (DR. PRATAP CHANDRA CHUN-DER): (a) to (c). The said magazine has carried some articles purporting to present the authors' views on certain themes or topics dealt with in the Ramayana and Bhagwat Geeta. It is open to public to comment on or criticise them. The Government has no proposal to intervene in the matter.

Plant Quarantine Measures

4371. SHRI C. K. JAFFER SHA-RIEF: Will the Minister of AGRICUL-TURE AND IRRIGATION be pleased to state: (a) whether the Plant Protection Adviser to the Government of India has pleaded for intensifying plant quarantine measures;

(b) whether several new diseases, hitherto unknown in our country, have come to Government's notice; and

(c) if so, the names of these diseases and the steps Government have taken to prevent these diseases?

THE MINISTER OF AGRICULTURE AND IRRIGATION (SHRI SURJIT SINGH BARNALA): (a) to (c). As a result of the continual review of the plant quarantine facilities by the Plant Protection Adviser and the Government, with reference to the appearance of new plant diseases, the plant quarantine infra-structure has been progressively strengthened in the country during the last decade. Presently, the plans to establish 3 new Plant Quarantine and Fumigation Stations and to strengthen 21 Plan Qurantine and Fumigation Stations are in the process of implementation.

The two important new diseases which have come to Government's notice in the last few years are Groundnut Rust and Gram Powdery Mildew.

These diseases are being checked by:

(i) use of suitable chemicals; and/;or

(ii) directing research effort toevolve new resistant varieties.

Admission of handicapped Students in Central School, Gole Market New Delhi

THE MINISTER OF STATE IN THE MINISTRY OF EDUCATION, SOCIAL WELFARE AND CULTURE (SHRI-MATI RENUKA DEVI BARAKAT-AKI): (a) and (b). Yes, Sir. As there is a great demand for admissions in respect of limited number of seats available, the children, handicapped or otherwise, of the Central Government employees only could be considered for admission, priority being given to those with more transfers.

(c) and (d). Yes, Sir. The Children of Central Government employees belonging to Scheduled Castes and Scheduled Tribes even without transfers have been admitted in Kendriya Vidyalaya, Gole Market, New Delhi, against the quota reserved for them. Moreover, the children of Central Government employees in non-transferable posts are not debarred from admission______ they are, however, accorded lower priority as compared to children of transferable Central Government employees.
