THE MINISTER OF EDUCATION. SOCIAL WELFARE AND CULTURE (DR. PRATAP CHANDRA CHUNDER): (a) The Visiting Committee appointed by the University Grants Commission to assess the Fifth Five Year Plan requirements of the Faculty of Engineering & Technology of the Banaras Hindu University, in its report mitted to the Commission in April, 1977, observed inter-alia that equipment so far obtained for examining the structural and mechanical properties has been put to full use and much good work has been carried out. The Committee has also recommended that the Department should acquire certain additional equipment in phased manner to achieve its well defined objectives. According to the University Grants Commission, no complaint has been received regarding the misuse of funds by the Department.

- (b) According to the information furnished by the Banaras Hindu University, installation of the Diesel Generator was essentially for the uninterrupted functioning of the very Laboratory in which it has been housed and no damage, whatsoever, has resulted in any of the consequential shifting.

Jute Cultivation Technique to Farmers
