THE MINISTER OF WORKS AND HOUSING AND SUPPLY AND RE-HABILITATION (SHRI SIKANDAR BAKHT) (a) In October, 1977, it was brought to the notice of the Delhi Wakf Board and the Government by the Mutwalli and Sayadanashin of Dargah Hazrat Sheikh Kalimullah Wali that he had permitted in November 1976 dealers in old woollen garments who were thrown out on the road as a result of the beautification of Jama Masjid area to use the portion of the graveyard adjacent to the Durgah for 2-1/2 months only on humanitarian grounds and these persons have continued to occupy the graveyard and their number was increasing day by day

- (b) On a personal visit by the Secietary Delhi Wakf Board it was found by him that a number of tem porary structures had sprung up by the side of the railing of the Durgah towards the east and in the southern portion of the Durgah semi-permanent and temporary structures were also found by him According to the Secretary Delhi Wakf Board no visible obstruction was apparently found in the passage leading to the Durgah from the eastern side
- (c) The matter of vacation of the Durgah land has been taken up by the Delhi Wakf Board with the Delhi Administration who is looking into the matter
