THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND IRRIGATION (SHRI BHANU PRA TAP SINGH) (a) The rate of duty on khandsarı sugar ıs 171 ad valorem. This rate is substantially lower than the duty levied on free sale sugar which was 45 per cent upto 15-11 77 and 271 per cent since 16 11-77

The majority of khandsarı producers are assessed under the compounded levy system which is not related to the quantity of khandsari produced but to the size of the centrifugal used in the process of manufacturing The incidence of duty under this system is substantially lower than the ad valorem rate or that on free-sale sugar

(b) and (c) Unlike vacuum pan sugar factories the Central Govern ment have left the khandsarı ındustry to junction without any controls is not subjected to levy like vacuum pan sugar and hence is able to sell its entire produce in the open market at whatever rates the forces of supply and demand dictate Government is fully aware of the agro base and em ployment potential of khandsarı indus try as compared to the vacuum pan sugar industry Representations for reduction of the weekly rates under the compounded Levy Scheme are being examined in depth, for decision in the Ministry of Finance
