The Members of Parliament and Non-official members shall have a two year term from the date of the first meeting of the Board. They shall however be eligible for renomination for a second term.

The Board in its first meeting held on November 2, 1977 resolved that a massive programme of adult education should be launched from 1978-79 to cover the vast segment of illiterate population within the age-group 15-35 as far as possible within five years of its launching. It also resolved make intensive preparations for this purpose and to advise Government in respect of such preparations it resolved to constitute a small committee. The current year would mainly be utilised for making such preparations. A Working Group has been set up by the Ministry in collaboration with the Planning Commission to work out programmes of action and financial estimates This task is not completed yet

World Bank Loan for Cashew Plantstion in Kerala

1127. SHRI C. K. CHANDRAPPAN: Will the Minister of AGRICULTURE AND IRRIGATION be pleased to state:

- (a) whether the World Bank has agreed to give a loan of Rs. 10 crore for raising Cashew plantation in the State of Kerala; and
- (b) if so, the details thereof and the reaction of the State Government and Central Government towards this offer?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE & IRRIGATION (SHRI BHANU PRATAP SINGH). (a) and (b). No,Sir, there is no separate World Bank-assisted project for cashew plantation in Kerala. However, there is an on-going Agricultural Development Project of Kerala, with World Bank credit of 30 million dollars (about Rs 27 crores). The credit is mainly meant for rehabilitation of coconut and contains a small component of cashewnut development. Of the 30 million dollars (about Rs. 27 crores), 1 million dollars (about Rs. 90 lakhs) is earmarked for rehabilitation of State-owned cashew plantation in approximately 2280 hectares and new plantation of about 1470 hectares, in the State of Kerala.

Loss due to non-clearance to Thein

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE & IRRIGATION (SHRI BHANU PRATA? SINGH) (a) Clearance to go ahead with the construction of Thein Dam had been held up due to inter State differences mainly regarding sharing the benefits of the Project amongst the States of Punjab, Jammu and Kashmir, Himachal Pradesh Rajasthan and Haryana Problem of irrigation benefits got resolved with the issue of Government of India Order of 24th March, 1976 determining shares of Punjab and Haryana in the surplus Ravi-Beas waters Regarding sharing of power benefits, as a result of several meetings of the Chief Ministers of the concerned States taken by the Union Minister of Agriculture and Irrigation along with the Union Minis ter of Energy and the final meeting taken by the Prime Minister on 3rd October 1977 all have agreed to the construction of Them Dam being taken up immediately even though some issues still remain to be settled More over till recently the major concerned States could provide barely adequate resources for the gigantic inter State Beas Project which is now in the final stage of completion

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE & IRRIGATION (SHRI BHANU PRATAP SINGH) (a) The National Commission on Agriculture in their report in 1976 has enunciated a strategy for increasing the present milk production in the country from 21 70 million tonnes to 44 17 in 1985 and 66 40 million tonnes in 2000 AD To achieve these targets, the thrust of the National Commission on Agriculture recom mendations are (1) replacement of low stock with crossbred cows and improved indigenous cows and Luffaloes (ii) intensive development in 113 districts covered by SFDA, MFAL and Operation Flood, each district to cover 50,000 cows and 25,000 buffaloes (iii) cattle & buffalo development in dis tricts served by Intensive Cattle Development-cum Milk Marketing Pro jects and those covered by Drought Prone Areas Programme, Command
