THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AF-FAIRS (SHRI S. KUNDU) (a) Yes, Sir. The Policy Planning Committee is composed of the Secretaries of the Ministry of External Affairs with the Foreign Secretary as the Chairman. Whenever specific issues concerning their departments and areas of competence are concerned, other Secreturies of the Government of India are invited as special invitees. The Joint Secretary in the Policy Planning Division is the Member-Secretary of the Policy Planning and Review Committee.

(b) Ya, Ser. The General denises that the Committee thould have greater contacts with experts in the actdemic and cultural fields to take manimum advantage of available expertise on foreign policy in the country. There is already in existence liaison between Committee and concerned scholars, academicians at Jawaharlal Nehru University, Institute of Defence Studies and Analys and the Indian Council of World Affairs. The question of institutionalising these contacts on a continuing basis is being looked into.

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI S. KUNDU) : (a) to (c). An Indian Airlines Boeing-737 aircraft was hijacked to Lahore on September 10, 1976, while on a scheduled flight (No. 491) between Delhi and Jaipur on the Delhi-Jaipur-Aurangabad-Bombay sector.
