संबार संबास्थ में राज्य मंत्री (भी नरहरि प्रसाद बुखदेव साम):(क) विमानेतर शाखा पोस्टमास्टरों को, गांवों में, जिनमें एहाड़ी भौर दर्फीने इलाके मी शामिल हैं, डाक दितरण का काम केवल ऐसे मामलों में सौंपा जाता है जिननें कायंभार के प्राधार पर प्रतन से दितरण एबेंटों/पामीण पोस्टर्मनों का प्रोजित्य नहीं सिद्ध होता। पहाड़ी भौर वर्छति इलाकों में, समान्यत: डाक-वितरण संबंधी काम बहत कम रहता है।

Indian Red Cross Society

4880. SHRI UGRASEN: Will the Minister of HEALTH AND FAM/LY WELFARE be pleared to refer to the reply given to Short Notice question No. 5 on 24-6-1977 regarding disappearance of eight blank cheques in 1975 and subsequently a sum of about Rs. 35,000 found, withdrawn from the Red Cross Society, New Delh's account with the State Bank of India and state:

(a) was any action taken against persons responsible for safety of cheque books;

(d) whether in a raid by Delhi Excise Department, large quantity of liquor was found in June, 1977, at the Red Cross Society, New Delhi's premises without licences; if so, full report about the same; (c) whether there is age limit for retirement in Red Cross Society and what is the age of the present Secretary General;

(d) why Lok Sabha polling day i.e. 16th March. 1977, in Delhi was not declared a holiday in Red Cross Society, New Delhi; and

(c) who opened the newly constructed marble Red Cross building and what the tablet reads?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FA-MILY WELFARE (SHRI JAGDAMBI PRASAD YADAV): (a) The case is under investigation by the Police. However, the bankers have provisionally paidlo the Society a sum of Rs. 50,100 withdrawn from the Society's account under forged signatures in February/March, 1975-1

(b) There has been no raid whatsoever by the Delhi Excise Department at the Red Cross Society's premises.

(c) Yes. Ordinarily, the age of retriement of the regular employees of the Society is 60 years but the Society may, in special circumstances, continue or employ a person beyond that age. The age of the present Secretary-General of the Society is 68 years.

(d) The office of the National Headquarters was closed on the Lok Sabha polling day *i.e.* March 16, 1377 and some workers who were engaged on urgent work were also asked to take time off to cast their voices.

(e) The then acting President of India who is also the President of the Indian Red Cross Society opened the newly constructed headquarters building of the Society on 25-5-1977.

Low pay to extra Departmental Post Masters

4881. SHRI PADMACHARAN SAMANTASINHERA: Will the Minister OF COMMUNICATIONS be pleased to state:

(a) whether Government are aware that the Extra-Departmental Post Masters working in remote rural areas draw the lowest pay, when Government have decided the minimum salary policy; (b) what is the total number of employees working in the extra Departmental Post Offices;

(c) whether Government are sympathetic to raise their pay; and

(r) if so, what will be their pay and when they are to get it?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICA-TIONS (SHRI NARHARI PRASAD SUXHDEO SAI): (a) Considering the fact that the Branch Peatmasters work for only limited hours a day the allowance payable to them is not considered inadeguate.

(b) As on 31-3-77 the total number of Extra Departmental agents was 222495.

(c) and (d). The wage structure of the Branch Postmasters is under review.

Cost of Production of a pair of Rail Wheel

4882. SHRI JSUKHENDRA SINGH: Will the Minister of STEEL AND MINES be pleased to state:

(a) the cost of production of one pair of rail wheels with axle and at what price they are sold to the Railways; and

(b) the cost of production of one ton of steel in the various steel plants and at what price it is being exported?

THE MINISTER OF STATE IN THE MINISTRY OF STEEL AND MINES (SHRI KARIA MUNDA). (a) and (b). The cost of production of different categories of steel varies (from plant to plant depending on several factors like product mix, capital cost etc. Similarly, the export prices for different categories of steel are subject to fluctuations depending on International market conditions. Railways are being supplied a pair of rail wheels with axle at a price of Rs. 4308 (exclusive of excise duty and JPC cess).

(ख) यह सोसाइटी एक स्वतंत्र सहकारी संस्या है प्रीर यह डाक-तार विभाग के नियंत्रण में फ्रांने वाली एक इकाई नहीं है। इसलिए, प्रपने कर्मचारियों के कत्याण के बारे में श्यान देता सोसाइटी का काम है।

Setting up of an Export oriented Alumi. nium Plant in M.P.

4884. SHRI SURYA NARAIN SINGH: Will the Minister of STEEL AND MINES be pleased to state;

(a) whether Russian experts have submitted a report to government for setting up an export oriented aluminium plant in Madhya Pradesh;

(b) if so, the details therein; and

(c) the reaction of Government thereto?

THE MINISTER OF STATE IN THE MINISTRY OF STEEL AND MINES (SHRI KARIA MUNDA): (a) to (c). A featibility report was gor prepared by a Soviet agency for setting up an export-oriented alumina plant based on Mainpat bauxite deposits. The featbility report concluded that the exploitation of these deposits would not be economical for export of alumina. It was, therefore, not possible to proceed further in the matter.
