### Staving of order in the Bharat Heavy Electricals Limited

THE MINISPER OF STATE IN THE MINISTRY OF INDUSTRY (KUMA-RI ABHA MAITI): (a) and (b). Bharat Heavy Electricals Ltd., Hardwar have firm orders for execution upto 1979-80. The total requirements of power plants for the country for a period of 5 years are being identified by the Government. This would naturally lead to flow of more orders and it is expected that the Hardwar plant will be fully booked. Besides efforts are being made to secure orders from outside the country.
