# Proposal to set up a Coal-tar Factory in Durgapur

#### SHRI C. R MAHATA:

Will the Minister of STEEL AND MINES be pleased to state

- (a) whether the Government of West Bengal have submitted a proposal to set up a coal-tar distillation factory in Durgapur with the participation of HSL; and
- (b) if so, Government's reaction thereto?

THE MINISTER OF STEEL AND MINES (SHRI BIJU PATNAIK). (a) and (b) No proposal to set up a coaltar distillation fartory with the participation of Hindustan Steel Ltd, has been received in this Ministry. According to a communication ceived from the Government of West Bengal, however, it appears that Durgapur Chemicals Ltd. a State Government undertaking, has obtained a letter of intent for setting up a coaltar chemical complex at Durgapur This project is based on the assumption that coal-tar from TISCO and IISCO would be made available for use as raw material; it has been suggested to the State Government that they should discuss this matter further with both TISCO and IISCO before the project can be pursued further This Ministry has also taken up this issue with both the Steel Plants

# Burma visit of Minister of External Affairs

THE MINISTER OF EXTERNAL AFFAIRS (SHRI ATAL BIHARI VAJ-PAYEE) (a) Briefly, I had an exchange of views with the Burmese leaders on recent developments in India and Burma, bilateral questions, regional problems in South and South-East Asia and international questions—political and economic—of common interest

- (b) Yes, Sir It was agreed to expedite the demarcation of the remaining portion of Indo-Buima boundary under the agreement of 1967 and to resume technical negotiations on the delimitation of the maritime boundary in the Andaman Sca and the Gulf of Martaban at an early date
- (c) Yes, Sir The two governments have always extended cooperation to each other in combating the activities on their soil of insurgent elements from the other side. Neither side is propared to permit its soil to be used for hostile activities against its friendly neighbour.
