The project will be considered for being taken up after the surveys are completed and reports are examined. Survey for extension of Rangapara-Balipara line to Bhalukpong and Murkongselek Pasghat line have already been completed and the Reports are under examination. A decision for taking up these projects would depend upon the availability of resources and the clearance by the Planning Commission.
4	Mizoram	Survey for Lalaghat/Dalabazar-Sawang/Ajal is in progress at the cost of N.E. Council. The project will be considered after the surveys are completed and reports examined.
5	Sikkim	There is no proposal at present for having a rail link connecting Sikkim.
