- (c) Out of the total length of 167.5 kms of Nagpur-Amla Section, 16.5 Kms between Teegaon-Chichonda only had been approved for doubling and this was opened to traffic in June, 1970.
- (d) No further work of doubling of the remaining 151 Kms has yet been approved However, provision of crossing stations between Multai and Chichonda, Metpanira and Kohli and Teegaon and Chichonda (Block hut) at an approximate cost of Rs. 64.26 lakhs and tokenless block working at an approximate cost of Rs 1766 lakhs are at present under execution to augment the line capacity for handling increased traffic in the immediate future.

(b) The sections Erode-Olavakkot and Alwaye-Ernakulam are fully doubled On the Shoranur-Always section doubling between Pudukad-Irinyalakuda (10 km) has been opened to goods traffic on 14-11-77, while the doubling between Mullurcarai-Wadakancheri is expected to be ready for opening by April 1978.

Doubling of the following sub-sections has recently been sanctioned and it will take about 3 years for their completion, subject to availability of funds --

- (i) Shoranur Mullurcarai-8.07
- (ii) Wadakancheri Mulagunnathukavu-745 km
- (iii) Trichur Pudukad-13 74 km.
- (iv) Chalakudi Angamali-15.41 km.

Complaint by Fabricators Association

EIL is mainly concerned with the execution of large projects in respect . of petroleum refinery, fertilizers, petrochemicals, non-ferrous metallurgy, ocean engineering etc EIL has a system of keeping a list of vendors in the large scale, medium-scale and small scale sectors for procurement of materials for these plants Over the years EIL has examined and placed on its list large number of vendors in the small scale sector on whom it places orders depending upon the quality, quantity, time price and geographical location of such vendors. But the materials, equipment and parts that are procured by EIL for the above industries are generally of an extremely sophisticated nature and the ability ; of the Units in the small scale sector to supply such materials of the requir-
