Grant of Bus Licences to S.C. and S.T.

1975. DR. BHAGWAN DASS RA-THOR: Will the Minister of SHIP-PING AND TRANSPORT be pleased to state:

(a) how far the targets announced by the Ministry and/or by the Admimistration of the State under the Central Government for granting bus licences for plying buses on the routes to the persons belonging to Scheduled Castes and Scheduled Tribes have been achieved so far during the current financial year upto the 31st January, 1978;

(b) whether even the Delhi Administration has net implemented this decision to the full extent; and

(c) if so, the names of the persons belonging to Scheduled Castes and Scheduled Tribes who were granted bus licences?

THE MINISTER OF STATE IN CHARGE OF THE MINISTRY OF SHIPPING AND TRANSPORT (SHRI CHAND RAM): (a) Reperwation for Scheduled Gastes pand Schedulad Tribes in the matter of grant of permits for transport vehicles can be provided for only after the Motor Vehicles Act, 1989, is suitably amended. A Bill to emend the act for this and some other purposes is likely to be introduced during the current session of Parliament. There is not statutory quota or reservation for Scheduled Castes and Scheduled Tribes in this matter at present.

(b) and (c) Do not arise.
