6392. SHRI AGHAN SINGH THA-KUR: Will the Minister of RAIL-WAYS be pleased to state:

- (a) the demand for molasses tanks in Delhi Division during last three months:
- (b) the number of tanks supplied for molasses during the last three months to Delhi Division; and
- (c) whether Government propose to meet the demand in view of short supply of molasses?

THE MINISTER OF STATE IN THE MINISTRY OF RAIL WAYS (SHRI SHEO NARAIN): (a) and (b). As on 1-1-1978, demands for 12 molasses tanks were pending. During the period I-1-78 to 31-3-78 fresh demands for 135 tanks were received against which 117 tanks were supplied and loaded.

(c) As on 5-4-78 the outstanding demands were only for 18 tank wagons with the oldest date of registration being 23-3-78. These are also being met.

- (c) how the provisions of reservation in promotion contained in office memorandum No. 27/2/71/Est. (SCT) dated 27th November, 1972 issued by Cabinet Sectt.; are being implemented
