Railway Link between Agartala and Amam

SHRI JANARDHANA POOJARY:

Will the Minister of RAILWAYS be pleased to refer to the reply given to Unstarred Question No. 135 on the 21st February, 1978 regarding Railway link between Agartala and Assam and state:

(a) whether the present Chief Minister of Tripura. Nripen Chakravarty called on him on 12th January, 1978 to press for the immediate extension of the railway line from Dharamnagar to Kumarghat and thereafter to Sabroom via Agartala;

(b) whether the people of Tripura observed one day's peaceful bandh demanding extension of Railway facilities; and

(c) if so, what steps, if any, are being taken on the same?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SHEO NARAIN): (a) and (b). Yes.

(c) Dharmnagar-Kumarghat line in Tripura is one of the six lines proposed by the North Eastern Council for construction in the North Eastern Region. The Flanning Commission has appointed a Committee to examine these proposals in depth and a decision on the construction of the lines would depend upon the recommendations of the Committee, which has been allowed 8 months to finalise its report.
