- (a) whether it is a fact that the Recruiting Office at Gurgaon which was functioning there for the last 50 years or so was got shifted to Bhiwam by the ex-Defence Minister during Emergency period;

- (c) whether Government are contemplating to re-open the recruiting office at Gurgaon; and

THE MINISTER OF DEFENCE (SHRI JAGJIVAN Recruiting Office at was functioning since 1963, was shifted to Hissar, and not to Bhiwani, in October 1976. This was done while adjusting jurisdiction of various Recruiting Offices in Haryana State.

(b) Approximately 1.7 per cent of the Army strength are from District of Gurgaon, as it was before reorganisation of Districts in Haryana. Army personnel belonging to Gurgaon District reported killed during the last two Wars are as under—
