Thermal Power Plant at Karnataka

7439. SHRI C. K. JAFFER SHA-RIEF: Will the Minister of ENERGY be pleased to state:

- (a) whether Karnataka State have pleaded for a thermal power plant in that State;
- (b) whether power shortage has been noticed by Government which is the main hinderance for the improvement of industries in that State; and
- (c) if so, whether Government would consider it sympathetically to establish a thermal power plant either in Mangalore or Hospet?

THE MINISTER OF ENERGY (SHRI P. RAMACHANDRAN); (a) Yes, Sur.

- (b) There is power shortage in Karnataka State. Therefore, the present availabilty of power is not adequate to meet the full requirement of industries in the state.
- (c) Provision has been made in the five year plan commencing April 1, 1978 for a thermal power station in Karnataka State. A proposal for a thermal power station at Raichur with two units of 210 MW is presently under consideration.

1974-75 - Rs 19.64 crores

1975-76 __ Rs. 14.65 crores

1976-77 -- Rs. 29.47 crores

(b) The Foreign Exchange earned by these Undertakings is part of general receipts of the Government and is utilised in accordance with the general policy of the Government.
