## Rural Health Scheme

438. SHRI DURGA CHAND: Will the Minister of HEALTH AND FAMI-LY WELFARE be pleased to state:

- (a) whether Government have made any modifications in the Health Scheme for Rural Areas;
- (b) if so, what are the details thereof;
- (c) the number of villages in each State proposed to be covered under the scheme during the next five years; and
- (d) whether it is proposed to involve voluntary agencies and educational institutions in the implementation of the health scheme?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI JAGDAMBI PRASAD YADAV) (a) and (b). No, the Government of India have, however, allowed adaptation of the scheme to the local conditions obtaining in certain areas.

- (c) It is proposed to cover all the villages in each State, which accepts the scheme, by April 1932.
- (d) Yes, whenever voluntary organisations are willing to participate, their services are proposed to be utilized for training the community health workers. It is proposed to assign them specific areas and work.

As regards educational institutions, a beginning is being made by involving the medical colleges of modern medicine in taking care of three Primary Health Centres each
