THE MINISTER OF WORKS AND HOUSING AND SUPFLY AND RE-HABILITATION (SHRI SIKANDAR BAKHT). (a) and (b) Yes, Sir

(c) The National Capital Regional Plan was approved by the High Powered Board in September, 1973.

A sum of Rs. 518 lakhs has so far been sanctioned as Central loan assistance to the State Governments concerned for the development of the regional towns.

(b) A legislation to control air pollution in the country is being processed and the necessary Bill will be introduced in the Parliament soon. Meanwhile to combat the hazards caused by the smoke emitted by chimneys attached to furnaces installed by the industries, the Delhi Administration are taking necessary action as provided under the Bombay Smoke Nuisances Act. 1912. tended to the Union Territory of Delhi, and Rules framed thereunder. Remedial measures for preventing the fly-ash pellution from the Indrapractha Power Station are also being taken by the Government

Allotment of Nitrogen Fertilisers to Puniab

THE MINISTER OF AGRICUL-TURE AND IRRIGATION (SHRI SURJIT SINGH BANALA) · (a) No, Sır. During Kharif 1978 (ie February to July, '78), Punjab State has been allotted 1,21,000 tonnes of nitrogenous fertilisers on the basis of their net agronomic requirements. Requirements for Rabi 1978-79 will be assessed in the month of July, 1978 and allotment made accordingly.
