## Closure of Sardar Vallabhbhai Patel Regional College of Engineering and Technology

(a) whether it is a fact that due to some epidemical disease Sardar Vallabhbhai Patel Regional College of Engineering and Technology, Surat has been closed for fifteen days;

(b) if so, the nature of the disease; and

(c) whether any deaths of students have also occurred?

THE MINISTER OF EDUCATION, SOCIAL WELFARE AND CULTURE (DR. PRATAP CHANDRA CHUN-DER): (a) and (b). The students of Sardar Vallabhbhai Patel Regional College of Engineering and Technology, Surat, started becoming sick from the second week of February 1978 onwards, most of them getting high fever. The Institute's Doctor who was treating most of the student patients, identified the cause to virus infection of the nature of influenza. The College, therefore, was closed for two weeks from 27th February, 1978 to 12th March, 1978 and re-opened from 13th March, 1978. The College is running in a normal way.

(c) A student of First year viz., Shri Krishna Kumar, was admitted in Sir P. T. General Hospital, Surat on 1st February, 1978. He was having fever and later on started bleeding. The student died on 5th February, 1978 when his parents were by his side. This student was not keeping well earlier also.
