# रेलवे बोर्ड में प्रतिनियुक्ति पर प्रविकारी

1123. श्वी नवाव सिंह बौहान : क्या रेल मंत्री यह बताने की कृपा करेंगे कि :

(क) क्या रेलवे बोर्ड में प्रतिनियुक्ति पर ग्राये ग्रधिकारी कब तक ग्रपने पुराने विभागों को वा९स जायेंगे;

(ख) क्या ये प्रधिकारी स्थायी तौर पर रेन विभाग में खपा लिये जायेंगे प्रथवा जिन पदों पर वे कार्य कर रहे हैं उन पदों के लिये नई नियुक्तियां की जायेंगी; ग्रौर

(ग) क्या वर्तमान सरकार नियुक्तियों तथा पदोन्नतियों के बारे में भूतपूर्व सरकार जैसी ही नीतियां ग्रपना 'रही है ग्रथवा इस सम्वन्ध में कोई परिवर्तन किये गये हैं ?

रेल मंबालय में राज्य मंत्री (श्री जिव नारायण): (क) रेल मंत्रालय में कुछ पद रों से हैं जो रेलवे से भिन्न ग्रन्य विभागों के प्रधिकारियों को प्रतिनियुक्ति पर लेकर, ठार्य-काल के ग्राधार पर, भरे जाते हैं। यह र्जार्य-काल, ग्राम तौर पर 3 में 5 वर्ष तक का होता है। कार्यकाल समाप्त हो जाने पर, प्रतिनियुक्ति पर ग्राये सभी ग्रधिकारियों की सेवाएं उनके मूल विभागों के हवाले कर दी जाती हैं।

(ख) प्रतिनियुक्ति पर ग्राये ग्रधि-कारियों को रेल विभाग में समाहित कर लेने का, <mark>श्रामतौ</mark>र पर, प्रश्न नहीं उठता, क्योंकि भर्ती के नियमों में इस प्रकार माये मधिकारियों को समाहित कर लेने की कोई व्यवस्था नहीं है।

(ग) जहां कहीं द्यावश्यक होता है, नियुक्तियां त्रोर पदोन्नतियां, कार्मिक त्रौर प्रशासनिक सुधार विभाग तथा संघ लोक सेवा प्रायोग के परामर्श से, समय-समय पर बनाए गए नियमों के त्रनुसार की जाती हैं।

## Lack of Accommodation in Mussoorie Express

1124. SHRI JAGANNATH SHAR-MA: Will the Minister of RAILWAYS be pleased to state:

(a) whether Government are aware of the inconvenience caused to thousands of passengers travelling from Dclhi to Kotdwara and vice-versa by the Mussoorie Express due to lack of accommodation in this train;

(b) whether it is also a fact that several representations in this regard have been received by the Government; and

(c) if so, what steps Government have taken to alleviate the sufferings faced by the passengers going and coming from Kotdwara?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SHEO NARAIN): (a) An analysis of the traffic has revealed that about 246 passengers travel daily between Delhi and Kotdwara. For these passengers there are 3 through coaches running between Delhi and Kotdwara.

(b) Yes.

(c) Introduction of a direct train

between Delhi and Kotdwara is at present operationally not feasible for want of spare line capacity enroute and due to inadequate terminal facilities at Delhi and Kotdwara. Dieselisation of 41/42 Mussoorie Express in order to augment the through coaches between Delhi and Kotdwara will be considered alongwith other similar demands as soon as adequate number of Diesel locomotives are available.

#### Demand for starting a Train from Delhi to Kotdwara

1125. SHRI JAGANNATH SHAR-MA: Will the Minister of RAIL-WAYS be pleased to state:

(a) whether Government are aware of the long standing demand of the people belonging to Pauri and Chamoli (Garhwal) districts to start a direct train from Delhi to Kotdwara and vice-versa; and

(b) if so, what steps Government have taken to ameliorate the difficulties of passengers of these districts?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SHEO NARAIN): (a) Yes.

(b) Introduction of a direct train between Delhi and Kotdwara is at present operationally not feasible for want of spare line capacity enroute and due to inadequate terminal facilities at Delhi and Kotdwara.

### Burning of Bogies of Kumaon Express

1126. SHRI SHAMBHU NATH CHA-TURVEDI: Will the Minister of RAILWAYS be pleased to state:

(a) whether following the death of student at a flower show at Agra the Kumaon Express was held up at Bichpuri railway station and two bogies set on fire betwee nthe night of 12/13th February, 1978;

(b) if so, the details thereof and the damage caused;

(c) whether any police squad was travelling on the train; and

(d) whether the miscreants have been identified and arrested?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SHEO NARAIN).: (a) Yes.

(b) While Kumaon Express was in motion after its scheduled stoppage at Bichpuri Railway Station at 21.55 hrs on 12-2-1978, the alarm chain was pulled and the train was brought to a halt in front of B.S. Rajput Agricultural College, situated near the track on the east side. About 100/125 persons stated to be students of this college got down from the train and some of them went to the Guard and Engine Crew and did not allow the train to start. They created panic among the passengers who got down from the coaches. The students sprinkled petrol/kerosene oil on 2 coaches Nos. FS 3746 and FCS 3705. set fire to them and ran away. The Fire Brigade from Agra Fort reached the site and brought the fire under control. There was no loss of life ricr was there any injury to any of the passengers. Only 2 coaches were involved and burnt. The loss is estimated at Rs 80,000/-. The train suffered a detention of 5.45 hrs. The Government Railway Police Agra Fort has registered a case vide crime no No 25/ 78 under sections -.1 and 436 IPC and 108 IRA on 13-2-1978.

(c) Two Police Constables of Government Railway Police Agra Fort were escorting the train under reference.

(d) No.
