THE MINISTER OF AGRICUL-TURE AND IRRIGATION (SHRI SURJIT SINGH BARNALA): (a) No, Sir. However preliminary material with regard to cotton crop 1977-78 at Central State Farm, Jawalgera has since been collected but the complete enquiry is likely to take some more time.

Pay Scales of College Librarians and D.P.Es in Punjab

4026. SHRI BHAGAT RAM: Will the Minister of EDUCATION, SOCIAL WELFARE AND CULTURE be pleased to state:

- (a) whether college librarians and D.P.Es on the recommendation of the U.G.C. and the Ministry of Education Government of India, had been enjoying the parity of pay scales with the College lecturers since 1959;
- (b) whether Government recommended similar pay scales to College Librarians and D.P.Es on the line of teachers as has previously been recommended by the U.G.C. from time to time:
- (c) on what basis the parity was established and disturbed afterwards:
- (d) whether Government followed the principle of uniform pay scales to College Librarians and D.P.Es as has been done in the case of College lecturers on the basic norms of "equal pay for equal work"; and
- (e) whether Government have recommended the revised pay scales for College Librarians and Lecturers of Punjab equal to the college lecturers and Librarians of Delhi?

THE MINISTER OF EDUCATION, SOCIAL WELFARE AND CULTURE (DR. PRATAP CHANDRA CHUNDER): (a) to (e). In the past revisions, Librarians and physical education personnel were included in the scheme aparently to upgrade their scales of pay which were very low. During the 1966—71 revision, teachers,

librarians and physical education personnel were all placed in scales of pay which by and large, corresponded to those obtaining in most of the organised services under Government.

The revised salary scales aproved by Government from January 1, 1973 for university and college teachers are a definite improvement on their existing. scales. While considering the revised scales for librarians and physical education personnel, the Sen Committee appointed by the University Grants had taken note of the Commission parity which existed earlier, but felt that the nature of work and duties, workload, responsibilities and above all, the minimum educational qualifications of a lecturer are materially different from those of a director of physical education. The Committee also observed that in the past, due attention was not given to the fact that if qualifications and job requirement are aproximately the same, the scales of pay should also be the same. The revised scales for librarians and physical education personnel aproved by the Government on the recommendations of the UGC are therefore on the basis of the standard replacement scales recommended by the Third Pay Commission for corresponding categories of Central Government employees, and are not based on parity with the scales of pay of teachers. These revised scales are with reference to the scales of pay existing on December 31, 1972 and no distinction has been made, as between Universities and Colleges located in different States and Union Territories.
