4040. SHRI V. G. HANDE: Will the Minister of WORKS AND HOUSING AND SUPPLY AND REHABILITATION be pleased to state:

- (a) whether huge mass of construction debris is lying and the conditions of roads/lanes and bye-lanes is very unsatisfactory and there is a mass growth wild vegetation in the area of newly constructed Type I Quarters (Clive Square) Block K. and Type II Quarters in Block C. (Albert Square) D.I.Z. area of Rama Krishna Ashram Marg, New Delhi;
- (b) whether Government have received any representation forwarded by a member of Parliament in this regard, if so, the details thereof and the action Government have taken thereon;
- (c) whether these quarters have no cross ventilation and substandard material have been used in the construction of these quarters and the concerned Chief Engineer gave an assurance to the residents of these areas to get the defects removed immediately; and
- (d) if so, what remedia! steps Government propose to take to develop parks and lawns in these areas and to make the quarters liveable?

THE MINISTER OF WORKS AND HOUSING AND SUPPLY AND RE-HABILITATION (SHRI SIKANDAR BAKHT): (a). No, Sir. Roads and bye-lanes have been constructed with water bound macadum. New Delhi Municipal Committee is currently laying services like sewerage, water supand electricity. This activity damages the road surface which will be repaired bitumen carpet prowork of N.D.M.C. vided after the around these quarters is over. The surroundings where these constructed quarters are occupied have been cleared of the building materials. Building material is lying only in the area

where the construction activity is still going on.

- (b) Yes, Sir. The representation mention inter-alia about drains for balconies and staircases, warping of doors, numbering of quarters, inadequacy of water supply, provision of dust bins, provisions of additional fans in the quarters, provision of sweepers for common areas and faulty working of enquiry office. The points have already been examined and remedial action is being taken wherever neces-
- (c). Area of ventilation is adequate and in keeping with building bye-law. Materials used in the work are not substandard. Minor defects in buildings are being attended to.
- (d) The whole area is under redevelopment. As soon as the building activities are over, the development of parks and lawns will be taken up.

## Shortage of D.M.S. Milk

The installed handling capacity of the D.M.S. is 3.75 lakh litres of milk per day and the demand for milk in Delhi substantially exceeds the installed capacity of the D.M.S. Therefore second dairy with a handling capacity of 4 lakh litres of milk per day has already been set up at Patparganj.
