## Floods in Delhi due to rise in Yamuna Lovel

4124. SHRI C. K. JAFFER SHARIEF: Will the Minister of AGRICULTURE AND IRRIGATION be pleased to state:

- (a) whether several villages have been flooded in Delhi due to the rise in the level of river Yamuna recently;
- (b) if so, the loss of life and property as a result thereof; and
- (c) the compensation given to the victims, if any?

THE MINISTER OF AGRICUL-TURE AND IRRIGATION (SHRI SURJIT SINGH BARNALA): (a) Several villages in Delhi territory have been flooded/affected due to recent floods in Yamuna.

Villages of Gopalpur, Wazirabad and Jagatpur lying between the river and the right marginal bund, the village of Jaitpur downstream of Okhla Weir and parts of land belonging to these villages were inundated.

As a result of breaches in the Drain No. 6 and Bawana escape, villages in the area were also flooded.

(b) and (c). No loss of life has so far been reported and damage to property crops etc. is being assessed.

## Committee for Flood Control in Brahmaputra

4125. SHRI JANARDHANA POO-JARY: Will the Minister of AGRI-CULTURE AND IRRIGATION be pleased to state:

- (a) whether Government have decided to set up an expert committee to examine the question of flood control in Brahmaputra; and
  - (b) if so, its composition?

THE MINISTER OF AGRICUL-TURE AND IRRIGATION (SHRI SURJIT SINGH BARNALA): (a) A High-level Committe has been set up by Government for giving expert technical direction and advice for storage of the waters of the Brahmaputra and Meghna systems for multipurpose benefits including flood control.

(b) The Committee is headed by the Chairman, Central Water Commission and has as its members the senior officers of Central Water Commission, Central Electricity Authority, Survey of India, National Remota Sensing Agency, India Meteorological Department and the Brahmaputra Flood Control Commission, and a retired Chairman of the Central Electricity Authority as a non-official member.

(b) The price and procurement policy for paddy for 1978-79 season will be decided in September-October, 1978 in the light of the recommendations of the Agricultural Prices Commission and the views expressed by State Governments.
