- (a) the number of pending passport applications as on 31st March, 1978 with regional passport office-wise; and
- (b) the steps taken by Government to clear the arrears?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SAMARENDRA KUNDU):
(a) A statement showing the number of passport applications pending as on 31st March, 1978, Regional Passport Office-wise, is laid on the table of the House.

(b) Government have sanctioned a total of 375 additional posts of clerks for the Regional Passport Offices with effect from February, 1978 for clearing the arrears. In addition, 23 posts of Passport Officers (Assistant Passport Officers, Public Relations Officers and Superintendents) have been created

during the period May 1977 to April, 1978 to cope with the arrears as well as the increasing work load of the Regional Passport Offices.

Passports in respect of a large number of these pending applications could not be issued because the applications were not complete and information or documents or photographs were lacking. The Regional Passport Offices have whitten to the Applicants again asking them to supply the requisite documents/information for want of which the applications are pending: the applicants have been informed that they should supply the documents within three weeks.

As a result of these measures, the effective arrears in the Regional Passport Offices have been progressively reduced and brought down to 1,75,892 as on June 30, 1978.

Retirement Age of Scientists in ICMR

604. SHRI GANGADHAR APPA BURANDE: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state: (a) whether it is a fact that the retirement age of medical scientists in the ICMR is 60 and is liable to be extended upto the age of 62 unlike in the Government of India; and

(b) if so, the reasons thereof?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMI LY WELFARE (SHRI JAGDAMBI PRASAD YADAV): (a) According to the Bye-laws governing the conditions of service of the employees of the Indian Council of Medical Research, the age of retirement of scientific/technical personnel is 60 years. They may, however, be retained in service upto the age of 62 years in exceptional cases.

(b) The Indian Council of Medical Research is an autonomous organisation. The Bye-laws governing the age of retirement of the employees of the Council are on the same lines as those of the other similar autonomous organisations like the All India Institute of Medical Sciences, New Delhi and Post-graduate Institute of Medical Education and Research Chandigarhetc, and were adopted so that the expertise and knowledge of the concerned scientific and technical personnel is fully utilised to the maximum advantage of the country.

Issue of Share of State owned Public Ltd. Companies to workers

- (a) whether the Government propose to issue shares of the State owned Public Ltd. Companies like IISCO. Burnpur, HSL, Bokaro.
