Accommodation Problem of P. & T. Staff in Garo Hills

711. SHRI P. A. SANGMA: Will the Minister of COMMUNICATIONS be pleased to state:

(a) whether the employees of P. and T. Department posted at Tura and elsewhere in the District of Garo Hills, Meghalaya, are facing acute accommodation problems due to want of Departmental quarters and rented houses, and if so, whether Government will consider construction of staff quarters at Tura; and

(b) whether it is a fact that while other central employees posted in Garo Hills District are entitled to house rent allowance and hill allowance, the P & T employees are not entitled to any of these allowances, if so, whether Government will consider grant of house rent allowance and hill allowance to P & T employees in Garo Hills?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI NARHARI PRASAD SUKHDEV SAI): (a) There is generally considerable difficulty in obtaining rented housing accommodation in hilly areas. At Tura, 12 departmental quarters are available, for a staff of 93, giving a percentage of 12.9 per cent against the all-India average of 8.47 per cent.

(b) No, Sir. No Central Government employee posted in the District of Garo Hills, is entitled to house rent and hill compensatory allowances as these stations do not fulfil the conditions prescribed in this regard.
