(a) a list of firms under the control of the Birla group;

(b) initial and current paid up capital of each firm;

(c) details of inter-corporate investment made by the Birla group of firms during the last 3 years; and

(d) whether it is a fact that intercorporate investment is one of the weapons of a business house to keep the companies under its control?

THE MINISTER OF LAW, JUSTICE AND COMPANY AFFAIRS (SHRI SHANTI BHUSHAN): (a) and (b). Assuming registration under section 26 of the M.R.T.P. Act, 1969, as the basis for grouping, Statement I [Placed See No. LT\_2586/78] in Library. hereto gives a list of undertakings which appear to belong to the Birla group, or are otherwise inter-connected with such undertakings, and the latest available information regarding their current paid-up-capital. As regards the initial capital, the actual amount of initial share subscription would be negligible generally, as it is usually comprised of only the statutory minimum number of shares required to be held by the subscribes to the Memorandum of Association for purposes of incorporating a company under the Companies Act.

Details of the undertakings (c) which are seen to have made intercorporate investments in Indian Companies during the accounting years closing in 1975, 1976 and 1977 are shown in Statement 2 [Placed in Library. See No. LT-2586/78] to the extent information is available from the balance sheets.
