## Conversion of Bangalore-Mysore Metre Gauge

1381. SHRI RAJSHEKHAR KOLUR: Will the Minister of RAILWAYS be pleased to state:

- (a) the progress made regarding the conversion of Bangalore-Mysore metre gauge line into the standard guage:
- (b) the target date fixed for such conversion and whether work is going on according to schedule; and
  - (c) if not, reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SHEO NARAIN): (a) A survey for the project has been carried out and the report is under examination in consultation with the Planning Commission. No decision has been taken about the construction of this project so far.

## Conversion of Rangalore-Guntakal M.G.

1382. SHRI RAJSHEKHAR KOLUR: Will the Minister of RAILWAYS be pleased to state:

- (a) whether the work regarding the conversion of Bangalore-Guntakal metre gauge line to the standard gauge is progressing according to schedule;
- (b) if the progress is slow, the reasons thereof; and
- (c) when the conversion programme is expected to be completed?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SHEO NARAIN): (a) to (c). The work on the gauge conversion of Bangalore-Guntakal line has been progressing at a slow pace on account of shortage of resources. No firm target date for its completion can be given at this stage.
