Consequently the Chairman of the School had decided to close down the school for an idenfiite period since 7th August, 1978. The Management of the school has already been directed by the Education Directorate. Delhi Administration to reinstate the employees of the school whose services were terminated. The school has now reopened on 16th August, 1978. It is understood that the Management has now taken back the three dismissed employees in the school.
