Liaison Officers appointed for Representation of SC and ST in services

4044. SHRI B. C. KAMBLE: Will the Minister of LAW, JUSTICE AND COMPANY AFFAIRS be pleased to state:

- (a) how many liaison Officers are appointed in each of the departments in your Ministry, relating to representation in services for the Scheduled Castes and Scheduled Tribes as per Government Brochure, Chapter 15, and since when each of them appointed and the status of each of them;
- (b) what are the reports of each of these Liaison Officers under Para 15.4 of the said Brochure during the last three years, submitted to the Secretary Additional Secretary etc. and what action was directed by the latter and whether said action as directed was taken and with what result; and
- (c) will the Government lay on the table of the House the copies of the said reports, directions and the action taken as per (b) above, if not why not?

Stoppage of Link Express at Parvatipuram Station

- (a) whether 51 Up/52 Down Link Express starting from Waltair (S.E. Railway) will stop at Parvatipuram Town Station instead of Parvatipuram Station or not;
- (b) if not, then on what basis was the present provision made since Parvatipuram town station was already the recognised Express and Mail Trains halting Station;
- (c) whether this was done on recommendation of the local sub-collector whose residence happens to be near the Parvatipuram Station; and
- (d) what action Government propose to take in the matter?

(b) t₀ (d). There are two express trains viz. 89/90 Madras-Bokaro Steel City Express and 51/52 Link Express running on Titlagarh-Vizianagaram section. There have been representations for providing the stoppages of these trains at one of the two stations instead of the other from public, Passenger Associations, State Government etc. In view of these, it has been decided to stop 89/90 Express at Paravatipuram Town and 51/52 Express at Parvatipuram station in accordanc with the policy to stagger the stoppages of various services in the overall passengers interest.
