- 8. The posts of the Chief Engineer and Dy. Conservator are lying vacant from 1-1-1979 and 1-3-1979 respectively. The post of Marager is not vacant. A Selection Committee has been appointed to make recommendations for selection of the candidates for the posts.
- 9. As a result of the various measures taken by the Government and the Bombay Port authorities, the waiting period for general cargo vessels has come down from 65 days to around one month. The number of ships waiting for berth has reduced from 58 days (on 17-3-1979) to 26 days (on 30-4-1979).
- 10. The man days lost from April, 1978 to March, 1979 were about 84,400 as a result of late report of half-an hour by the shore labour The Port ha, been working to over 90 per cent of its capacity and there is hardly any cushion left to absorb problems of labour bottlenecks of transportation system, bunching of ships, weather constraints, etc.

Contracts to Foreign Firms for Building Forts

9407. SHRIMATI MOHSINA KID-WAI: Will the Minister of SHIPPING AND TRANSPORT be pleased to state:

- (a) the names and number of the fereign firm; which have been awarded contracts during the last two years for building ports in the country; and
- (b) the names of the sites where the work i, in progress?

THE MINISTER OF STATE IN CHARGE OF THE MINISTRY OF SHIPPING AND TRANSPORT (SHRI CHAND RAM): (a) and (b). During the last two years there have been three cases of award of contracts for port works to firms that were either of foreign origin or were Indian firms which executed the work with freign collaboration.

In New Mangalore Port a contract was awarded for rock dredging to an Indian firm having foreign collaboration with M/s. Ingenior F. Selmer, a Norwegian Firm and the work is in progress.

In the second ca e, the work was awarded to a Yugoslav Firm, M/s. Ivan Milutinovic-MIM for residual dredging work in Mormugao Port which has since been completed.

The third case relates to the laying of a Submarine Pipeline in the Bombay Harbour. The work was entrusted to O N.G.C. who got it executed through M/s Oceanic Contractors Inc., U.S.A. This work has been completed.
