(a) whether it is a fact that in 1971, the Indian Ambassador in Burma, Shri Baleswar Prasad wrote two letters to the Government of India for ceremonially bringing the Chair of the Head of the Provisional Government of Free India, Netaji Subhash Chandra Bose, to India;

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIPS (SHRI SAMARENDRA

KUNDU): (a) to (d) Although the Ministry did not receive. in 1971, any letter on this subject from the then Indian Ambassador in Burma, it did receive a communication from an official of the Indian Embassy. While it is not customary for the Government to divulge the exchange of correspondence between the Headquarters and its missions abroad. it may be mentioned that the official simply forwarded the letter from the custodian of the chair in which he had offered the chair to the Government of India. It appears that no decision was taken at that time.

(e) and (f) On January 23, 1979, i.e. Netaji's birthday, during my visit to Burma in connection with the celebration of the 'India Week', I received the historic chair on behalf of the Government of India. Arrangements for bringing the chair to India and other pertinent questions are currently engaging the attention of the Government of India.
