Recruitment of SC/ST Members to Junior Posts in Central and State Services

THE MINISTER OF STATE IN THE MINISTRY OF HOMI: AFFAIRS AND IN THE MINISTRY OF LAW, JUSTICE AND COMPANY AFFAIRS (SHRI S D. PATIL): (a) Yes Sir A two-day conference of Recruiting Agencies like State Public Service Commissions etc. was organised by Staff Selection Commission on 24th and 26th March, 1979.

(b) The conference concluded with several recommendations. Some of the main recommendations of the conference are as follows:--

(i) to make up the shortfall in recruitment against vacancies reserved for Scheduled Castes and Scheduled Tribes, special recruitment may be held exclusively for them. (11) Where necessary and possuble, additional examination centres may be set up in areas where Scheduled Castes and Scheduled Tribes population is concentrated.

(ni) Adequate number of preexamination training centres may be set up for providing coaching facilities to candidates belonging to Scheduled Castes and Scheduled Tribes.

(iv) Facilities like hostel accommodation, typewriters etc. should also be made available.

(v) Extensive publicity may be given about examinations and rectuitments in which reservations for Scheduled Castes/Tribes exist.

(v1) Recluiting agencies may be vested with the discretion of relaxing t_0 the extent necessary. qualifications relating to experience prescribed for recruitment to various posts and services reserved for Scheduled Castes/Tribes.
