Target date for Commissioning of Kalpakkam Atomic Power Plant

- 322. SHRI O. V. ALAGESAN: Will the Minister of ATOMIC ENERGY be pleased to state:
- (a) what were the target dates set down/announced from time to time for the commissioning of the Kalpakkam Atomic Power Plant:
- (b) what is the latest date set for its commissioning; and
- (c) what i_s the escalation in the cost of the plant due to the delays in the commissioning of the plant?

THE PRIME MINISTER (SHRI MORARJI DESAI): (a) and (b). The target dates set for commissioning of Unit-1 of Madras Atomic Power Plant from time to time were December, 1973, December 1974, November 1975, July 1976, June 1977, December 1978 and December 1979. The current target completion date is May, 1980 for Unit-1. For Unit-2, the target dates set down earlier were November, 1976, June 1979, June, 1980 and July, 1981. The current target date for completion is March, 1982.

(c) The increase in the Project cost is estimated to be Rs. 62.67 crores. This is partly due to escalation in prices (Rs. 34.42 crores) and partly due to

other reasons such as design change, increase in scope of work and new works etc.

(ख) चंक उत्पादन कीं बस्तु लघु क्षेत्र में विकास के लिए झारक्षित है, झतः जसा कि प्रैस ने सूचल किया है, कंपनी को, जो बड़े क्षेत्र में है, झौद्योगिक लाइसेंस नहीं, बस्कि झाशय-पत्न झन्य बातों के साथ साथ इस शर्त पर स्वीकृत किया गया है कि कंपनी उत्पादन के प्रथम वर्ष से ही समस्त उत्पादन का निरन्तर निर्धाल करेगी। यह नई झौद्योगिक नीति के झनुरूप ही है। फिर भी प्राप्त झन्यावेदनों को 'ह्यान में रखते हुए, इस प्रकार की जांच की जा रही है।

Ban on Communal Organisation

- 325. SHRI HITENDRA DESAI: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) will Government consider banning communal organisation; and
- (b) does Government consider R.S.S. to be a communal organisation?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI DHANIK LAL MANDAL):
(a) Organisations whose activities are prejudicial to the maintenance of

communal harmony and to the interest of national integration can be dealt with under the provisions of the Unlawful Activities (Prevention) 1967, as amended by the Criminal Law (Amendment) Act, 1972. The question whether the provisions of this law should be invoked in respect of any organisation is examined by Government from time to time in the light of the material available in respect of the activities of the organisation.

(b) Government has no information to indicate that the R.S.S. can deemed to be an 'unlawful association' as defined in the Unlawful Activities (Prevention) Act.

Low Cost Economy

326. SHRI K. RAMAMURTHY: Will the Minister of PLANNING be pleased to state:

- (a) has the Planning Commission resolved the view-point of the Prime Minister, which is repeated frequently, about "Low cost economy" and the Reserve Bank Governor's categorical statement as announced him in the Seminar held in Pune on January 2, 1979 on Pool of expert counsel that simple living has no credence and is also not a factor contributing to economic growth, while the Sixth Five Year Plan is being formulated; and
- (b) whether Sixth Plan proposals will lead to low-cost economy or not?

THE MINISTER OF STATE IN THE MINISTRY OF PLANNING (SHRI FAZLUR RAHMAN): The views expressed by the Governor, Reserve Bank in Pune on January 2, 1979, which wore not correctly reported in the press, are not inconsistent with emphasis on reducing costs in the economy or the approach of the Sixth Plan. He said that there was need to improve the living standards of the poor.

(b) Reduction in costs of industrial and agricultural production can be achieved by increased productivity in all sectors of the economy, economy in the use of capital, and the provision of inputs, including credit, at the right time and place at reasonable prices. These are the policies recommended in the Draft Five Year Plan (1979-83).

Setting up of Newsprint Plant at Bhadravati Karnataka

327. SHRI JANARDHANA POOJA-RY: Will the Minister of INDUSTRY be pleased to state:

- (a) whether a newsprint plant is being set up at Bhadravati in Karnataka State; and
 - (b) if so, the details in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (SHRI JAGDAMBI PRASAD YA-DAV); (a) and (b). Mysore Paper Mills are implementing a project for the manufacture of 75,000 tonnes per year of newsprint at Bhadravati, Civil works are in progress and plant and machinery have also started arriving at site. The project is expected to be commissioned by 1980-81.
