- shortage of power.
- industrial unrest and strikes particularly at ports.
- unprecedented floods in many States like U.P., Bihar, West Bengal etc.
- reduced availability of imported raw cashewnuts and some difficulties in obtaining raw nuts locally.
- (v) Transport bottlenecks and congestion at major ports like Calcutta and Bombay.
- (vi) Deliberate policy of Government to restrict/control export of certain commodities to enable sufficient domestic availability at reasonable prices and to thus reduce the social cost of exports
- (c) and (d). A continuous study is undertaken by the organisations like TDA, IIFT, State Trading Corporation etc, to explore the prospects of exports commodity/countrywise. Task Forces were appointed to look into the problems and suggest ways for increasing production and exports to other countries in respect of dynamic sectors viz. · (1) Leather and leather products; (ii) Gems and Jewellery; (iii) Handicrafts; (iv) Electronics; (v) Project exports; (vi) Furniture; (vii) Agricultural products; (viii) Export services; and (ix) Export from small scale sector. An Inter-Ministerial Empowered Committee has been constituted for ensuring speedy examination and follow up action on the recommendations.
