योजना मंत्रालय में राज्य मंत्री (श्री फ़ाज़लरहमान) :

(क) और (ख). उत्तर प्रदेश की छठी पंच वर्षीय योजना को अभी तक अन्तिम रूप नहीं दिया गया है। इस योजना की प्रवधि के लिए राज्य विद्युत कार्यक्रम अभी भी विचारधीन है।

(a) the amount of financial assistance earmarked by the Central Government for implementing land reforms in Karnataka; and

(b) what is the actual amount provided for this purpose so far?

THE MINISTER OF STATE IN THE MINISTRY OF PLANNING (SHRI FAZLUR RAHMAN): (a) Central assistance is provided for the State Plan as a whole in the form of block grants and block loans and not for individual schemes/programmes.

Employment generated during 1978

1298. DR. BALDEV PRAKASH: SHRI AMAR ROY PRADHAN:

Will the Minister of PLANNING be pleased to state:

(a) the total employment generated in the year 1978 by the changed employment generation policy of Government;

(b) a broad outline of the employment generation policy; and

(c) total number of unemployed in the country at present and the expected annual rise in this number?

THE MINISTER OF STATE IN THE MINISTRY OF PLANNING (SHRI FAZLUR RAHMAN): (a) Estimates are not available of the quantum of employment generated in the economy from year to year.

(b) The employment strategy of the Draft Plan (1978—83) is:

(1) to adopt an employment-intensive sectoral planning;

(2) to regulate technological change to protect and enhance employment; and

(3) to promote area planning for full employment.

The inter-sectoral allocations of investment and the determination of output targets adopted in the Draft Plan (1978—83) are based on the above strategy.

In addition to the sectoral production plan, block level plans for the achievement of full employment are also envisaged in 2000 blocks to start with and an additional 300 blocks to be taken up each year over the plan period.
