maintenance of shrines and holy places in India and Pakistan at an Inter-Dominion Conference, but subsequently turned down the proposal for the reason that the matters proposed for discussion were either already agreed upon or were under scrutiny of a se-parate body. The Government of India have again impressed on the Government of Pakistan the need for

## STEEL PIPES AND TUBES (PRICES)

36. Dr. Amin: Will the Minister of Commerce and Industry be pleased to (a) whether it is a fact that steel pipes and tubes of the same size and type are sold by various stockists at different prices even though there is

price control over their distribution;

(b) whether Government have considered the possibility that importers, by furnishing fictitious invoices, may have their prices approved by the Government while at the same time in collaboration with foreign shippers, they may have reserved the margin of profit and allowed it to accumulate in foreign countries, thus extensively raising the prices to the Indian consumer; and sumer; and

(c) if the answer to part (a) above be in the affirmative, whether Government propose to devise some means for bringing about uniformity in the prices of pipes and tubes, the distribution of which is controlled by the Government?

The Minister of Commerce and Industry (Shri T. T. Krishnamachari):
(a) to (c). Indigenous production being negligible, Indian requirements of steel pipes and tubes are met almost entirely by imports. The controlled prices at which dealers are required to sell the pipes and tubes are based on the landed cost of the relevant consignment. The landed cost heing difon the landed cost of the relevant consignment. The landed cost being different in each case depending on the time and country of import, it is inevitable that the controlled prices of the same size and type of tubes sold by various stockists sometimes differ.

It is not proposed to fix a uniform controlled price owing to the difficulties involved.

I recognise that there is a possibi-ty that importers, by furnishing lity that importers, by furnishing fictitious invoices in collusion with the foreign suppliers, may get their pri-ces fixed at unjustifiably high levels, but with Government's present policy of issuing licences for imports freely and consequent competition amongst the various importers, we need have 252 P S D
