The Deputy Minister of Railways and Transport (Shri Alagesan): (a) A statement giving the required information is laid on the Table of the House. [See Appendix VIII, annexure No. 5.]

- (b) and (c). An Expert Committee to examine certain matters relating to the improvement of the headwater supply of the river Hooghly was set up on the 28th July 1952. The Committee finished its work and submitted its report on the 8th November 1952

795. Shri Thimmaih: (a) Will the Minister of Railways be pleased to state how many vacancies of Class Towere filled up in Mysore State Railway Traffic Department gration up till now?

- (b) How many applications were received from Scheduled Castes people for class IV vacancies in Traffic Department of the said Railway?
 - (c) How many are appointed?

'The Deputy Minister of Railways and Transport (Shri Alagesan): (a) 270 in Traffic Department of ex-Mysore Railway area.

(b) and (c). Information regarding the number of applications received from Scheduled Castes candidates is not available but 30 Scheduled Castes candidates have been appointed.

Indian People's Famine Trust Fund 796. Shri Karni Singhii: Will the Minister of Food and Agriculture be pleased to state whether Government propose to grant any subsidy from Indian People's Famine Trust Fund to alleviate distress of famine-stricken people of Bikaner and Jodhpur Divisions (Rajasthan)?

Written Answers

The Minister of Food and Agriculture (Shri Kidwai): The Board of Management, which sanctions grants from the Indian People's Famine Trust Funds, will shortly consider this along with other areas.

KRISHNA DAM

797. Shri Viswanatha Reddy: Will the Minister of Transport be pleased to state:

- (a) whether any proposal has been received from the Government of Madras in respect of the strengthening of the Krishna Dam at Vizayawada; and
- (b) whether the proposed construction by the Government of India, of a bridge across Krishna River at Vizayawada, includes also a regulator for the current of water in the river?

The Deputy Minister of Railways and Transport (Shri Alagesan): (a) No, Sir.

(b) The site and design of the road bridge have not yet been settled.

WORKERS IN JUTE INDUSTRY

- 798. Shri Tushar Chatterjea: (a) Will the Minister of Labour be pleased to refer to the answer given to my unstarred question No. 17 asked on the 6th November, 1952 regarding workers in jute industry and state whether the information has been collected?
- (b) If so, what is the number of the permanent employees, the number of such employees who have not yet acquired the permanency right and also the number of those registered as 'Badliwala' in jute mills?

The Deputy Minister of Labour (Shri Abid Ali): (a) The information received so far is not complete. One State Government has yet to reply. Čertain clarifications are also being obtained in respect of the information supplied by the other State Governments.

FORCED LABOUR

799. Shri Morarta: (a) Will the Minister of Labour be pleased to state whether there is any existence of forced labour as defined in the International Labour Convention No. 29 in any of the Parts 'A', 'B' and 'C' States in India?

(b) If the answer to part (a) above be in the affirmative, which are the States which are having this 'type of labour and in what form does it exist?

Written Answers

(c) If the answer to part (a) above be in the negative, why the International Labour Organisation Convention No. 29 regarding forced labour is not ratified by the Government of India?

The Deputy Minister of Labour (Shrie Abid Ali): (a) and (b). Forced labour as defined in the I.L.O. Convention No. 29 is not countenanced by law in India Article 23 of the Constitution of India prohibits forced labour except when it is specially permitted by the State for public purposes. Section 274 of Indian Penal Code makes forced labour for private purposes a penal offence.

The Agricultural I abour Enquiry conducted recently by Government revealed that some kind of forced labour was in existence in 74 sample villages in the Punjab, Uttar I radesh, Bihar, Orissa, PEPSU, Madhya Bharat, and Jammu and Kashmir, Such forced labour in some cases took the form of contractual obligations to continue to service of the same employer till the loan advanced was cleared. In some other cases, it took the shape of depressed wages for attached workers who were not free to work with other employers, or of work by family members without separate remuneration or at a nominal wage. Since these facts came to light, the State Governments concerned have taken appropriate measures to eradicate forced labour and have reported that there is no longer any forced labour in existence as defined in the I. L. O. Convention.

(c) A statement explaining inter alia difficulties in ratification was placed before the Parliament on the 10th September. 1951. The main obstacle impeding ratification then was the exaction of forced labour under the Criminal Tribes Act, 1924. Some other enactments were also found to contain provisions permitting forced labour not allowed under the Convention. The Criminal Tribes Act has since been repealed. The other enactments have either been suitably amended or appropriate action for doing so is in hand. With these obstacles removed. Government will now consider the question of ratification after obtaining legal opinion.

EMPLOYMENT OF CHILDREN

800. Shri Morarka: (a) Will the Minister of Labour be pleased to state whether the Factories Act, 1948 and

- the Employment of Children Act, 1938, have been applied to all the Parts 'B' and 'C' States in India?
- (b) Is the employment of children still prevalent in any of the Parts 'A', 'B' and 'C' States?
- (c) If the reply to part (b) above be in the affirmative which are the industries and in which States the children are employed?

The Deputy Minister of Labour (Shri Abid Ali): (a) The Factories Act. 1948, and the Employment of Children Act, 1938, have been applied to all Parts 'B' and 'C' States except the State of Jammu and Kashmir.

(b) and (c). The Factories Act, 1948, permits the employment of children between 14 and 15 years of age subject to certain restrictions regarding the period of employment ct. The Employment of children Act, 1938, prohibits the employment of children below 14 years in workshops wherein any of the processes set forth in the Schedule to the Act is carried on. On the basis of information available, a statement showing the industries in which children between 14-15 were employed in factories during 1950 in the various States is laid on the Table. [See Appendix VIII, annexure No. 6.]

So far as the employment of children below the prescribed age-limits in contravention of the statutory requirements is concerned, enquiries already made show that children are employed in a few industries. The attention of the hon. Member is, in this connection invited to the reply given to the Starred Question No. 2756 put by Shri Saniivayva on the 3rd April 1951.

MINIMUM AGE FOR EMPLOYMENT AT SEA

- 801. Shri Morarka: (a) Will the Minister of Transport be pleased to state what is the minimum age of employment of children at sea?
- (b) What are the reasons for the non-ratification of the I.L.O. Convention regarding minimum age for employment at sea?

The Deputy Minister of Railways and Transport (Shri Alagesan): (a) The minimum age of employment of children at sea on ships registered in India is 14 years subject to certain exceptions specified in section 37B of the Indian Merchant Shipping Act, 1923.

- (b) On the subject of minimum age of employment of children at sea, the I.L.O. have so far adopted the following three Conventions:—
- (i) Minimum age Trimmers and Stokers) Convention, 1921 (15)
