the net expenditure, i.e., cost less income, cannot be readily ascertained at this stage. A sum of Rs. 42,100/which was fully utilised, was given to the U. P. Postal Circle for opening of post offices in 1952-53.

Written Answers

(b) The number of Post Offices to be opened in conformity with the policy announced by the Government in the House on 28-3-1953 will be worked out. The indication of the exact number cannot be given at present.

Indian Council of Agricultural Research (Extension Programme)

- 851. Shri B. K. Das: Will the Minister of Food and Agriculture be pleased to state:
- (a) the details of the extension programme carried out by the Indian Council of Agricultural Research during the year 1952;

The Minister of Agriculture (Dr. P. S. Deshmukh): (a) (i) 15 pilot development projects;

- (ii) 21 extension training centres; and
- (iii) 3 extension wings to three agricultural colleges have been sanctioned.
- (b) An Agricultural Extension Commissioner with a nucleus staff has been appointed at the Centre. A Deputy/Joint Director of Extension with some staff has been appointed to be in overall charge of extension work in most of the States. Extension Boards at State, District, and Tehsil levels have also been set up in certain States.
- (c) Expenditure incurred at Central headquarters (including the Nilokheri Training Centre run directly by the Govt. of India) is Rs. 1,05,770/r upto February, 1953. Figures of expenditure incurred in the States are not available.
