duced in Bihar in the years 1952 and 1953; and

(b) the quantity of food grains to be supplied to Bihar during the year 1953?

The Minister of Agriculture (Dr. P. S. Deshmukh): (a) In 1952 the total quantity of rabi foodgrains including gram produced in Bihar was 572,000 tons. The quantity of paddy produced in Bihar that year was 2,712,000 tons in terms of cleaned rice. Figures for 1953 are not yet available.

(b) Bihar is not expected to require any rice allotment from the Centre during 1953. Their wheat requirements will be met in full.
