CHAMBAL PROJECT

6. **Shri Bheekha Bhai:** Will the Minister of **Planning** be pleased to state:

(a) the number of dams to be constructed across the river Chambal as envisaged under the Chambal Project included in the First Five Year Plan;

(b) the advantages of irrigation and power to Rajasthan and Madhya Bharat separately on the completion of the Project;

(c) the stages by which the project is to be executed and the time for the execution of these stages; and

(d) the terms of agreement, if any, between the two State Governments?

The Deputy Minister of Irrigation and Power (Shri Hathi): Two dams, the Gandhi-sagar dam and the Rana Pratap Sagar Dam, together with a diversion barrage at Kotah are envisaged in the first stage of the Chambal Project included in the first Five Year Plan.

The total area to be irrigated from this project is 1.2 million acres. The hydro-electric power installed in the first stage will be 60,000 K.W. Their distribution between the two States has yet to be agreed upon.

These questions are yet to be considered in consultation with the Governments of Rajasthan and Madhya Bharat.

CHAMBAL VALLEY PROJECT

7. **Shri Karni Singhji:** (a) Will the Minister of **Planning** be pleased to state whether any decision has been reached regarding the priority to be given to the Chambal Valley Project (Rajasthan)?

(b) If so, what is the order of priority?

The Deputy Minister of Irrigation and Power (Shri Hathi): The project has been included in the Five Year Plan. Certain details are to be shortly discussed with the Government of Madhya Bharat and Rajasthan.

SILK WEAVING

8. **Sardar Hukam Singh:** Will the Minister of **Commerce and Industry** be pleased to state:

(a) the total number of handlooms in the country engaged in silk weaving;

(b) the chief varieties of cloth manufactured by our silk weavers; and

(c) the raw materials used by the Banaras Silk and Brocade Industries?

The Minister of Commerce and Industry (Shri T. T. Krishnamachari): (a) About 97,000.

(b) Sarees, Dhoties, Turban cloth, Shirting, Suitings, Chaddars, Lungies, Scarves, Dupattas, Handkerchiefs, Mufflers, etc.

(c) The chief raw materials used are silk yarn, organzine, art silk yarn and gold and silver thread.

TRADE MARKS (REGISTRATION)

9. **Shri S. C. Samanta:** Will the Minister of **Commerce and Industry** be pleased to state:

(a) the number of applications received during the current year for registration of Trade Marks;

(b) how many of them have been registered up-to-date;

(c) whether nationals of any other countries excepting German and Japanese nationals have been permitted to apply for registration of Trade Marks;

(d) if so, from which countries; and

(e) the number of applications for registration from German and Japanese nationals this year?

The Minister of Commerce and Industry (Shri T. T. Krishnamachari): (a) It is presumed that the hon. Member desires information for the year 1952. If so, the number of applications received during that year was 4749.

(b) 33.

(c) Yes.

(d) Ceylon, U. K., Canada, Australia, Ireland, U.S.A., Switzerland, Sweden, France, Hungary, Spain, Holland, Belgium, Denmark, Italy, Czechoslovakia, Austria, Hongkong, Federation of Malaya, East Pakistan, Singapore, Morocco, Germany and Japan.

MEMORANDUM ON COMMUNITY PROJECTS SCHEME

11. Shri V. P. Nayar: Will the Minister of Planning be pleased to state:

(a) whether the attention of Government has been drawn to an article published on Page 1 of the English weekly "Delhi Times" published from Delhi on September 14, 1952, regarding a 60 page memorandum submitted by the American Ambassador in India, Mr. Chester Bowles, on the Community Projects Scheme and state whether the report is correct as to facts; and

(b) if so, whether Government propose to lay on the Table of the House a copy of the memorandum?

The Deputy Minister of Irrigation and power (Shri Hathi): (a) Yes, Sir. The report is not true to facts.

REGISTRATION OF INDUSTRIAL UNDERTAKINGS

12. Shri Bansal: Will the Minister of Commerce and Industry be pleased to state the number of industrial undertakings that have been registered up to 31st January, 1953 under the Industries (Development and Regulation) Act?

The Minister of Commerce and Industry (Shri T. T. Krishnamachari): 2209 industrial undertakings were

registered up to the 7th November 1952, which was the last date for registration under section 10 of the Industries (Development and Regulation) Act, 1951.

LICENSING OF INDUSTRIAL UNDERTAKINGS

13. Shri Bansal: Will the Minister of Commerce and Industry be pleased to state:

(a) the number of applications received up to 31st January, 1953 for the licensing of industrial undertakings, (i) for establishment of new industries and (ii) for the expansion of existing ones;

(b) the number of licences issued for each of the two categories; and

(c) the number of applications in the case of which additional information has been called for?

The Minister of Commerce and Industry (Shri T. T. Krishnamachari):

(a) Up to 31st January, 1953, 125 applications for licence were received. Of these,

(i) 71 were for the establishment of new industrial undertakings, and

(ii) 54 were for substantial expansion of existing ones.

(b) In the case of 29 applications for new undertakings and 24 for substantial expansions, the applicants have already been informed that licence would be issued to them subject to certain conditions. Six of the first category and 12 of the second have accepted the conditions, and licences have been issued to them.

(c) Additional information was called for in respect of 28 applications.

FACTORIES FOR WOOD SCREWS

14. Shri Radha Raman: (a) Will the Minister of Commerce and Industry be pleased to state what is the annual consumption of wood screws in India?

(b) What is the number of factories, registered and un-registered, in the country and how many of them are working at present?

(c) Is it a fact that most of these factories have been closed due to lack of demand for the indigenous manufactured goods?

The Minister of Commerce and Industry (Shri T. T. Krishnamachari):

(a) According to the Tariff Boards' estimates, the total Indian demand is about 5 million gross numbers per annum.

(b) There are 15 registered factories and 3 unregistered factories. All except 3 registered factories are in production.
