(c) Exports of pearls are recorded in official statistics under heading "Precious stones and pearls unset". The value of their exports in 1951-52 and 1952-53 was Rs. 22.7 lakhs and 32:2 lakhs respectively. Information regarding customs duty levied on imports of pearls is being collected and will be placed on the Table of the House in due course.
