pleased to state:

- (a) the total quantity of fish oils produced in India during the years 1947-48 to 1951-52;
- (b) the quantities of fish oils imported into India during the above period; and
- (c) the estimated annual requirements of fish oils in India?

The Minister of Commerce and Industry (Shri T. T. Krishnamachari):
(a) 40,629 gallons of shark liver oil were produced during the three years 1950, 1951 and 1952. Information for the previous years is not available.

- (b) A statement containing the information is laid on the Table of the House. [See Appendix III, annexure No. 49.]
- (c) The annual requirements can be roughly taken as 1 lakh gallons.

TRADE WITH EGYPT

ASBESTOS MANUFACTURED IN HYDERABAD STATE

347. Shri M. R. Krishna: Will the Minister of Works, Housing and Sup-

ply be pleased to state what percentage of asbestos sheets manufactured in Hyderabad State is being purchased by the Central Government for internal use?

The Deputy Minister of Works, Housing and Supply (Shri Buragohain): There is only one concern in Hyderabad State, viz. M/S. Hyderabad Asbestos Cement **Products** Hyderabad, who manufacture asbestos cement sheets. A rate contract for the supply of asbestos cement sheets has been concluded with this concern, for the period 1st June, 1953 to 30th April, 1954. Indents will be placed by Demanding Officers concerned on the Company direct. What quantities will actually be taken, cannot be estimated at present.
